COVID-19 Positive Cases Reported at Three Rivers Community Schools

Dear TRCS Parent/Guardian:

On January 25, 2022, we were notified of one (1) positive case of COVID-19 associated with a student at Andrews Elementary, three (3) positive cases of COVID-19 associated with students at Norton Elementary, one (1) positive case of COVID-19 associated with a student at Park Elementary, one (1) positive case of COVID-19 associated with a student at Three Rivers Middle School, three (3) positive cases of COVID-19 associated with students at Three Rivers High School and three (3) positive cases of COVID-19 associated with TRCS staff (Andrews Elementary, Three Rivers Middle School & Transportation). In compliance with current MDHHS emergency orders public notice of these school associated cases of COVID-19 are posted on our COVID-19 Dashboard located at: <https://trschoools.org/District/Portal/covid-19-dashboard>.

Andrews, Norton and Park will remain open at this time; Hoppin, TRMS & TRHS have transitioned to remote learning through 1/28/22 with a return to in-person on 1/31/22. Anyone identified as a close contact will be notified by a Three Rivers Community Schools Administrator as a part of the COVID-19 investigation process. Due to medical privacy laws, we are not able to release the names of the individuals with COVID-19.

It is our role to tell all families of Three Rivers Community Schools that we are moving forward under the guidance of the Branch-Hillsdale-St. Joseph Community Health Agency and that all measures have been taken to protect the wellbeing of your child(ren). These safety measures include frequent handwashing, sanitizing common touch areas and personal work space disinfecting.

Please monitor for the onset of symptoms related to COVID-19; including cough, shortness of breath, fever (Temp>100.4 F), chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell. If you note any change in the health of your child, please call your regular medical provider. Thank you for your understanding and continuing support in practicing good hygiene and safety protocols relative to COVID-19. We all need to work together during these challenging times.

El 25 de enero de 2022, se nos notificó sobre uno (1) caso positivo de COVID-19 asociado con un estudiante de Andrews Elementary, tres (3) casos positivos de COVID-19 asociado con estudiantes de Norton Elementary, uno (1) caso positivo de COVID-19 asociado con un estudiante de Park Elementary, uno (1) caso positivo de COVID-19 asociado con un estudiante de Three Rivers Middle School, tres (3) casos positivos de COVID-19 asociado con estudiantes de Three Rivers High School, y tres (3) casos positivos de COVID-19 asociado con el personal (Andrews Elementary, Three Rivers Middle School y Transportation). Andrews, Norton y Park permanecerán abiertos en este momento; Hoppin, TRMS y TRHS han hecho la transición al aprendizaje remoto hasta el 28/1/22 con un regreso en persona el 31/1/22. Cualquier persona identificada como contacto cercano será notificada por un administrador de las Escuelas de la Comunidad de Three Rivers como parte del proceso de investigación de COVID-19. Debido a las leyes de privacidad médica, no podemos divulgar los nombres de las personas con COVID-19.

Es nuestro papel decirles a todas las familias de las Escuelas de la Comunidad de Three Rivers que estamos avanzando bajo la guía de Branch-Hillsdale-St. Joseph Community Health Agency y que se han tomado todas las medidas para proteger el bienestar de su(s) hijo(s). Estas medidas de seguridad incluyen lavarse las manos con frecuencia, desinfectar las áreas comunes de contacto y desinfectar el espacio de trabajo personal.

Controle la aparición de síntomas relacionados con COVID-19; incluyendo tos, dificultad para respirar, fiebre (temperatura 100.4 F), escalofríos, temblores repetidos con escalofríos, dolor muscular, dolor de cabeza, dolor de garganta o pérdida reciente del gusto o el olfato. Si nota algún cambio en la salud de su hijo, llame a su proveedor médico habitual. Gracias por su comprensión y apoyo continuo en la práctica de buenos protocolos de higiene y seguridad en relación con COVID-19. Todos necesitamos trabajar juntos durante estos tiempos difíciles.
