COVID-19 Positive Cases Reported at Three Rivers Community Schools

Dear TRCS Parent Guardian:

On October 14, 2021, we were notified of two (2) positive cases of COVID-19 associated with students at Hoppin Elementary, three (3) positive cases of COVID-19 associated with students at Three Rivers High School, one (1) positive case of COVID-19 associated with Barrows Adult Education Center and three (3) positive cases of COVID-19 associated with staff at Three Rivers High School. In compliance with current MDHHS emergency orders public notice of these school associated cases of COVID-19 are posted on our COVID-19 Dashboard located at: <https://trschoools.org/District/Portal/covid-19-dashboard>

All schools will remain open at this time. Anyone identified as a close contact will be notified by a Three Rivers Community Schools Administrator as a part of the COVID-19 investigation process. Due to medical privacy laws, we are not able to release the names of the individuals with COVID-19.

It is our role to tell all families of Three Rivers Community Schools that we are moving forward under the guidance of the Branch-Hillsdale-St. Joseph Community Health Agency and that all measures have been taken to protect the wellbeing of your child(ren). These safety measures include frequent handwashing, sanitizing common touch areas and personal work space disinfecting.

Please monitor for the onset of symptoms related to COVID-19; including cough, shortness of breath, fever (Temp>100.4 F), chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell. If you note any change in the health of your child, please call your regular medical provider. Thank you for your understanding and continuing support in practicing good hygiene and safety protocols relative to COVID-19. We all need to work together during these challenging times.

Debido a las leyes de privacidad médica, no podemos divulgar los nombres de las personas con COVID-19.

Nuestro papel es decirle a todas las familias de las escuelas comunitarias de Three Rivers que estamos avanzando bajo la dirección de Branch-Hillsdale-St. Joseph Community Health Agency y que se han tomado todas las medidas para proteger el bienestar de sus hijos. Estas medidas de seguridad incluyen lavado de manos frecuente y desinfección, y limpieza / desinfección diaria de las instalaciones.

Controle la aparición de síntomas relacionados con COVID-19; incluyendo tos, dificultad para respirar, fiebre (temperatura > 100.4 F), escalofríos, temblores repetidos con escalofríos, dolor muscular, dolor de cabeza, dolor de garganta o nueva pérdida del gusto u olfato. Si nota algún cambio en la salud de su hijo/a, llame a su proveedor médico habitual. Gracias por su comprensión y apoyo continuo en la práctica de buenos protocolos de higiene y seguridad relacionados con COVID-19. Todos necesitamos trabajar juntos durante estos tiempos difíciles.
