COVID-19 Positive Cases Reported at Three Rivers Community Schools

Dear TRCS Parent/Guardian:

On October 25, 2021, we were notified of one (1) positive case of COVID-19 associated with a student at Andrews Elementary, three (3) positive cases of COVID-19 associated with students at Hoppin Elementary, one (1) positive case of COVID-19 associated with a student at Norton Elementary, one (1) positive case of COVID-19 associated with a student at Park Elementary, one (1) positive case of COVID-19 associated with a student at Three Rivers High School; we also had two (2) staff members at Norton Elementary and one (1) staff member at Hoppin Elementary test positive for COVID-19. In compliance with current MDHHS emergency orders public notice of these school associated cases of COVID-19 are posted on our COVID-19 Dashboard located at: <https://trschoools.org/District/Portal/covid-19-dashboard>

All schools will remain open at this time; however, due to an uptick in cases, the 1st & 2nd Grades at Hoppin Elementary will be transitioned to remote learning from October 26th through November 4th, with a return to in-person learning on Friday, November 5th. Anyone identified as a close contact will be notified by a Three Rivers Community Schools Administrator as a part of the COVID-19 investigation process. Due to medical privacy laws, we are not able to release the names of the individuals with COVID-19.

It is our role to tell all families of Three Rivers Community Schools that we are moving forward under the guidance of the Branch-Hillsdale-St. Joseph Community Health Agency and that all measures have been taken to protect the wellbeing of your child(ren). These safety measures include frequent handwashing, sanitizing common touch areas and personal work space disinfecting.

Please monitor for the onset of symptoms related to COVID-19; including cough, shortness of breath, fever (Temp>100.4 F), chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell. If you note any change in the health of your child, please call your regular medical provider. Thank you for your understanding and continuing support in practicing good hygiene and safety protocols relative to COVID-19. We all need to work together during these challenging times.

Estimado padre y tutor de TRCS:

Recientemente se nos notificó de uno (1) caso positivo de COVID-19 asociado con un estudiante de Andrews Elementary, tres (3) casos positivos de COVID-19 asociados con estudiantes de Hoppin Elementary, uno (1) caso positivo de COVID-19 asociado con un estudiante de Norton Elementary, uno (1) caso positivo de COVID-19 asociado con un estudiante de Park Elementary, y uno (1) caso positivo de COVID-19 asociado con un estudiante de Three Rivers High School ; también tuvimos dos (2) miembros del personal de Norton Elementary y uno (1) miembro del personal de Hoppin Elementary dieron positivo en la prueba de COVID-19. De conformidad con las órdenes de emergencia actuales del MDHHS, se publica un aviso público de este caso asociado a la escuela de COVID-19 en nuestro Panel de control COVID-19 ubicado en: <https://trschoools.org/District/Portal/covid-19-dashboard>

Todas las escuelas permanecerán abiertas en este momento; sin embargo, debido a un aumento en los casos, los grados 1 y 2 de HoppinElementary pasarán al aprendizaje remoto del 26 de octubre al 4 de noviembre, con un regreso al aprendizaje en persona el viernes 5 de noviembre. Cualquier persona identificada como un contacto cercano será notificada por un administrador de las escuelas comunitarias de Three Rivers como parte del proceso de investigación de COVID-19. Debido a las leyes de privacidad médica, no podemos divulgar los nombres de las personas con COVID-19.

Nuestro papel es decirle a todas las familias de las escuelas comunitarias de Three Rivers que estamos avanzando bajo la dirección de Branch-Hillsdale-St. Joseph Community Health Agency y que se han tomado todas las medidas para proteger el bienestar de sus hijos. Estas medidas de seguridad incluyen lavado de manos frecuente y desinfección, y limpieza / desinfección diaria de las instalaciones.

Controle la aparición de síntomas relacionados con COVID-19; incluyendo tos, dificultad para respirar, fiebre (temperatura > 100.4 F), escalofríos, temblores repetidos con escalofríos, dolor muscular, dolor de cabeza, dolor de garganta o nueva pérdida del gusto u olfato. Si nota algún cambio en la salud de su hijo/a, llame a su proveedor médico habitual. Gracias por su comprensión y apoyo continuo en la práctica de buenos protocolos de higiene y seguridad relacionados con COVID-19. Todos necesitamos trabajar juntos durante estos tiempos difíciles.
